

## NOTICE TO CONTRACTORS

CONTRACT: 2016 CONCRETE ALLEY & SIDEWALK INSTALLATION

Notice is hereby given that sealed proposals will be received in the office of the City Clerk of the City of South Milwaukee at the Administration Building, 2424 15<sup>th</sup> Avenue, South Milwaukee, WI 53172 **until 11:00 a.m. on Tuesday, August 16, 2016**, at which time they will be publicly opened and read for the public works improvement contract:

2016 CONCRETE ALLEY & SIDEWALK INSTALLATION

This contract will include 960 S.Y. of concrete alley replacement at 5 locations and 15,000 S.F. of various sidewalk square replacement, and miscellaneous quantities of concrete removal, excavation and crushed aggregate base as detailed in the project manual.

The document set describes items and quantities for bid proposal. It is anticipated that a contract will be awarded by the South Milwaukee Common Council on August 16, 2016 and work must be substantially complete by October 28, 2016, except as noted in the special provisions.

Document sets can be examined and obtained from the Office of the City Engineer, South Milwaukee City Administration Building, 2424 15<sup>th</sup> Avenue, South Milwaukee, Wisconsin 53172. There is a non-refundable fee of ten (\$10) dollars per set. Anyone desiring document sets by mail shall submit a fee in the amount of five (\$5) dollars per set in addition to the \$10 non-refundable fee to cover shipping and handling.

Proposal must be placed in a sealed opaque envelope addressed to: **“City Clerk, City of South Milwaukee, Wisconsin” and marked “Proposal for 2016 Concrete Alley & Sidewalk Installation”**. If the bid is sent by mail, the sealed envelope shall be enclosed in a separate mailing envelope with the notation **“Sealed Bid Enclosed”** on the face thereof.

The City of South Milwaukee reserves the right to reject any or all bids and waive any informalities in the bidding. No bids shall be withdrawn after the opening of the bids without the consent of the City of South Milwaukee, Wisconsin, for a period of thirty (30) days after the scheduled time for closing bids.

Prequalification forms for 2016 are required to be on file in the Office of the City Engineer for all contractors and subcontractors at least five days prior to bid opening. The Common Council’s decision as to qualification shall be final.

The minimum wage scale to be paid on this project by the contractor shall be in accordance with the minimum wage rates set forth in the Project Specifications as compiled by the State of Wisconsin Department of Workforce Development pursuant to 66.0903 Stats. The letting of this contract shall be subject to all applicable sections of Wisconsin Statutes.

All proposals must be submitted on a form provided for that purpose as issued within the Document Set, together with a certified check or a bid bond not less than five (5%) percent of the bid, payable to the City of South Milwaukee as a guarantee that, if the bid accepted, the bidder will execute and file the contract and a performance bond in the amount of one hundred (100%) percent of the total proposal price within ten (10) working days after the award of the contract. Failure to execute such contract and performance bond shall be cause for forfeiture of the check or bid bond as liquidated damages.
