NOTICE TO CONTRACTORS
(BID DATED AMENDED)

CONTRACT: MONTANA AVENUE RECONSTRUCTION

Notice is hereby given that sealed proposals will be received in the office of the City Clerk of the City of South Milwaukee at the Administration Building, 2424 15th Avenue, South Milwaukee, WI 53172 **until 11:00 a.m. on Tuesday April 18, 2017**, at which time they will be publicly opened and read for the above public works improvement contract which will include reconstruction of Montana Avenue Reconstruction with the following items of work:

- Concrete Curb & Gutter 3,800 L.F.
- Asphalt Pavement Milling 7,600 S.Y.
- Asphalt Surface (2") 1,250 TONS
- Asphalt Binder (2 ½") 1,200 TONS
- Quantities of sidewalk, curb ramp, unclassified excavation, base aggregate, and lawn restoration.

The document set describes items and quantities for bid proposal. It is anticipated that a contract will be awarded by the South Milwaukee Common Council on April 18, 2017 and the work shall be complete by July 21, 2017, except as otherwise approved by the City Engineer.

There is a non-refundable fee of twenty (\$20) dollars per set. Anyone desiring document sets by mail shall submit a fee in the amount of five (\$5) dollars per set in addition to the \$20 non-refundable fee to cover shipping and handling.

Prequalification forms for 2017 are required to be on file in the Office of the City Engineer for all contractors and subcontractors at least five days prior to bid opening. The Common Council's decision as to qualification shall be final.

Proposal must be placed in a sealed opaque envelope addressed to: **“City Clerk, City of South Milwaukee, Wisconsin”** and marked **“Proposal for Montana Avenue Reconstruction.”** If the bid is sent by mail, the sealed envelope shall be enclosed in a separate mailing envelope with the notation **“Sealed Bid Enclosed”** on the face thereof.

The City of South Milwaukee reserves the right to reject any or all bids and waive any informalities in the bidding. No bids shall be withdrawn after the opening of the bids without the consent of the City of South Milwaukee, Wisconsin, for a period of thirty (30) days after the scheduled time for closing bids.

All proposals must be submitted on a form provided for that purpose as issued within the Document Set, together with a certified check or a bid bond not less than five (5%) percent of the bid, payable to the City of South Milwaukee as a guarantee that, if the bid accepted, the bidder will execute and file the contract and a performance bond in the amount of one hundred (100%) percent of the total proposal price within ten (10) working days after the award of the contract. Failure to execute such contract and performance bond shall be cause for forfeiture of the check or bid bond as liquidated damages.
