SOUTH MILWAUKEE POLICE DEPARTMENT WEEKLY CRIME SUMMARY 5/20/19 - 5/26/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to 306 calls for service.

DISORDERLY CONDUCT

Officers were dispatched to a report of individuals involved in an argument in the 600 Block of Menomonee Avenue on May 25th. Upon arrival, officers spoke with a 43-year-old South Milwaukee woman and a 48-year-old South Milwaukee man. The woman claimed the man put his hands on her neck and poured a beer on her during the argument. The man was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Domestic Violence Battery.

Officers were dispatched to a report of two individuals involved in an argument in the 1200 Block of Minnesota Avenue on May 25th. Upon arrival, a 19-year-old South Milwaukee woman reported being struck and choked by a 21-year-old South Milwaukee man who had left the scene. The man was located in the area a short while later and he was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Domestic Violence Battery.

VEHICLE THEFT

A 30-year-old South Milwaukee man reported his 2010 Suzuki was taken from the 3300 Block of 5th Avenue on May 21st. The vehicle was recovered with front end damage on May 25th in the city of Milwaukee and a suspect was taken into custody by the Milwaukee Police Department. The investigation into this incident remains ongoing.

OPERATING WHILE INTOXICATED

Officers were dispatched to a report of a vehicle striking a fence and leaving the scene in the 1500 Block of Menomonee Avenue on May 20th. The vehicle was located behind a residence in the area with significant rear damage. Officers spoke with a 41-year-old Milwaukee man who admitted driving the vehicle to the residence. The man showed signs of impairment and he was arrested and taken to the police department where he was issued citations for Operating While Intoxicated-First Offense, Prohibited Blood-Alcohol Concentration, and Hit and Run to Property.

HIT AND RUN

Officers were dispatched to a report of an individual possibly being struck by a vehicle in the 1700 Block of Elm Avenue on May 21st. Officers spoke with a 62-year-old Milwaukee man who stated he was walking a dog when a white sedan driven by an older male nearly struck him. When the man shouted at the driver, the vehicle backed up and he was struck briefly in the chest by the driver's side mirror before the vehicle drove away. South Milwaukee Fire Department personnel responded but the man stated he did not need medical attention. Officers searched the area but were unable to locate the vehicle and the investigation remains open.

A 60-year-old South Milwaukee man reported two of his vehicles were struck and damaged in the 1700 Block of Monroe Avenue on May 23rd. Based on paint transfer and parts left at the scene, the striking vehicle appears to be a red 2000-2007 Dodge Caravan, Chrysler Town and Country, or Plymouth Voyager with passenger side damage. The area was searched but the striking vehicle was not located and the investigation remains open.
