

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 6/15/20 – 6/21/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **358** calls for service.

DISORDERLY CONDUCT

On June 17TH, officers were dispatched to a report of an argument in the 1300 Block of Minnesota Avenue. Officers spoke with a 33-year-old South Milwaukee man who stated a 36-year-old South Milwaukee woman was causing problems and refusing to leave his residence. The woman, who was intoxicated would not leave the area and was arrested. She was taken to the police station where she was issued a citation for Disorderly Conduct before being released to a responsible sober adult.

On June 18th, officers were dispatched to a report of an argument in the 1400 Block of Mackinac Avenue. Officers spoke with a 28-year-old South Milwaukee woman who stated a 36-year-old South Milwaukee man shoved her down some stairs. The man was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a Domestic Violence related charge of Disorderly Conduct.

RETAIL THEFT

On June 19th, officers were dispatched to a report of a retail theft that occurred at a business in the 200 Block of North Chicago Avenue. Employees reported an unknown female entered the business wearing employee attire and left with merchandise that wasn't paid for. The same female was later arrested by Greendale police following a similar offense at a business in their city. The female, identified as a 31-year-old Milwaukee woman, was issued citations for Retail Theft and Trespassing.

On June 15th, officers were dispatched to a report of an individual leaving a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 30-year-old Milwaukee man who store employees reported had concealed unpaid for items in his pants. Officers located the store items on the man and he was arrested. He was taken to the police station and issued citations for Retail Theft and Trespassing as he had been previously banned from the business for similar theft complaints.

OPERATING WHILE INTOXICATED

On June 19th, an officer on patrol noticed a vehicle stop in traffic for several seconds before continuing on. The officer followed the vehicle and initiated a traffic stop when it deviated from the traffic lane. The driver, a 23-year-old Milwaukee woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-1st Offense, and Prohibited Alcohol Concentration. She was released to a responsible sober adult.

On June 19th, an officer on patrol noticed a vehicle swerve and nearly strike a parked vehicle in the 1500 Block of Rawson Avenue. A traffic stop was initiated on the vehicle in the 1400 Block of Rawson Avenue. The driver, a 23-year-old Fox Point woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-1st Offense and Prohibited Alcohol Concentration before being released to a responsible sober adult.

On June 15th, officers were dispatched to the 1300 Block of Manitoba Avenue for a report of an unwanted vehicle parked in a driveway. Officers spoke with a 37-year-old South Milwaukee woman who stated a 39-year-old South Milwaukee man who appeared intoxicated parked his vehicle in a driveway that was not his and refused to move it. Officers located the vehicle parked in the driveway with the driver's door ajar. Officers spoke with the man who showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-1st Offense and Prohibited Alcohol Concentration. He was released to a responsible sober adult.
