

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 6/17/19 – 6/23/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **346** calls for service.

### **DISORDERLY CONDUCT**

A caller reported being threatened by a man via text message in the 700 Block of Milwaukee Avenue on June 23<sup>rd</sup>. Officers spoke with a 54-year-old South Milwaukee man and recovered a weapon from the residence. The man was arrested and referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct While Armed and Endangering Safety by Use of a Dangerous Weapon.

Officers were dispatched to a report of individuals arguing in the 2200 Block of 15<sup>th</sup> Avenue on June 18<sup>th</sup>. Upon arrival, officers spoke with a 32-year-old South Milwaukee man and a 77-year-old South Milwaukee man who were having a dispute in the backyard. The 32-year-old man stated this was an ongoing disagreement and the 77-year-old man was yelling at him and his family regarding wood that was piled up on Milwaukee County property. The 77-year-old man refused to identify himself and continued to be argumentative with officers. He was eventually arrested and issued a citation for Resisting/Obstructing before being released. He was also advised to contact the Milwaukee County Parks Department regarding his property complaint with the wood pile.

An officer on patrol observed a 42-year-old Oak Creek man urinating on the sidewalk in the 200 Block of North Chicago Avenue on June 21<sup>st</sup>. When asked why he didn't use a restroom in one of the many open businesses in the area the man stated he couldn't make it. He was arrested and issued a citation for Disorderly Conduct.

## **DAMAGE TO PROPERTY**

Officers were dispatched to a report of a vehicle driving recklessly in the area of the 200 Block of Southtowne Place on June 20<sup>th</sup>. Upon arrival, numerous witnesses stated the vehicle drove across grass in the area and provided officers with the license plate. Officers located the owner of the vehicle, a 22-year-old South Milwaukee man, in the 1400 Block of Missouri Avenue. He was arrested and issued citations for Reckless Driving and Criminal Damage to Property.

## **HIT AND RUN ACCIDENT**

Witnesses reported a truck struck the bottom of the train bridge over Marquette Avenue and continued driving on June 19<sup>th</sup>. A short time later, the truck was stopped by Oak Creek police officers in the city of Oak Creek. South Milwaukee officers responded and spoke with the driver, a 53-year-old Chicago man who stated he became lost and was unaware of the Truck Route in the area. He was issued citations for Hit and Run and Failure to Obey Signs.

## **RETAIL THEFT**

Officers were dispatched to a report of an individual taking items from a business in the 200 Block of North Chicago Avenue and leaving without paying for them. Upon arrival, store security personnel were speaking with a 26-year-old Milwaukee woman and a 35-year old Milwaukee man. It was determined the woman concealed items from the cosmetics department and attempted to leave without paying for them. The items were recovered and the woman was arrested and issued a citation for Retail Theft.
