

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 6/22/20 – 6/28/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **304** calls for service.

DISORDERLY CONDUCT

On June 26TH, officers were dispatched to a report of an individual passed out in the front yard of a residence in the 2000 Block of 17th Avenue. Officers located a 31-year-old South Milwaukee man who was intoxicated and sleeping. The man woke up and became argumentative after refusing to leave the area. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

On June 22nd, while officers were investigating an alleged domestic violence incident in the 1900 Block of 7th Avenue, an individual not involved in the original call began lighting off bottle rockets. Officers spoke with the 50-year-old South Milwaukee man who became belligerent and began yelling loudly. He was arrested and taken to the police station where he was issued citations for Disorderly Conduct, Resisting/Obstructing, and Fireworks Violations.

On June 28th, officers were dispatched to the 1200 Block of 15th Avenue after a 36-year-old South Milwaukee woman reported a 30-year-old South Milwaukee man threatened her with a weapon during an argument. The man and a 32-year-old Milwaukee woman left the area in a vehicle. Officers located the vehicle and conducted a traffic stop in the 300 Block of 15th Avenue. A handgun was turned over to officers at the residence. The man was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Recklessly Endangering Safety.

On June 23rd, officers were dispatched to the 2800 Block of South Chicago Avenue for a complaint of loud music and excessive noise. Officers spoke with a 50-year-old South Milwaukee man and a 45-year-old South Milwaukee woman who had guests over that were leaving. They were warned and advised on the noise complaint. As officers were leaving they heard loud yelling and observed the man continuing to make noise. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

On June 22nd, officers were dispatched to a report of a male striking a female in the 1900 Block of 7th Avenue. Multiple witnesses reported observing a male strike a female before both left the scene in a vehicle. Officers were able to identify the individuals involved in the incident as a 23-year-old South Milwaukee woman and a 23-year-old South Milwaukee man. The man was charged by the Milwaukee County District Attorney's Office with Felony Bail Jumping and Domestic Violence Related Battery and Disorderly Conduct.

OPERATING WHILE INTOXICATED

On June 25th, an officer on patrol observed a vehicle drive through the four-way flashing red light at the intersection at 15th and Rawson Avenues without stopping. A traffic stop was initiated in the 1600 Block of Rawson Avenue and the driver, a 25-year-old West Allis man, showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense and Failure to Stop for a Flashing Red Signal.

RETAIL THEFT

On June 25th, an individual left a business in the 200 Block of North Chicago Avenue without paying for items. Based on evidence from numerous similar incidents occurring at outlets of the business in other cities, the suspect was identified as a 29-year-old Milwaukee man. He was issued a citation for Retail Theft.
