

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 8/26/19 – 9/1/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **355** calls for service.

DISORDERLY CONDUCT

Officers were dispatched to a report of a man bothering customers at a restaurant in the 2700 Block of South Chicago Avenue on August 26th. Upon arrival, officers located an intoxicated 48-year-old South Milwaukee man who had been warned on panhandling in the past. Store employees and customers stated the man was following vehicles in the drive-thru asking for money and food. He was arrested and issued a citation for Disorderly Conduct.

A 48-year-old South Milwaukee woman reported having ongoing problems with a 29-year-old South Milwaukee woman in the 800 Block of Monroe Avenue on August 26th. Officers were shown a video where the 29-year-old woman yelled at the 48-year-old woman and spit on her car. The 29-year-old woman was issued a citation for Disorderly Conduct.

WARRANT ARREST

An officer on patrol observed a vehicle driving without brake lights and a traffic stop was initiated in the 800 Block of Monroe Avenue on August 29th. The driver, a 35-year-old South Milwaukee man, was found to have a confirmed warrant with the Milwaukee County Sheriff's Department. The man's driver's license was also revoked. He was arrested and issued a citation for Operating While Revoked before being turned over to deputies from the Milwaukee County Sheriff's Department on the warrant.

VEHICLE THEFT

A resident reported his 2009 Dodge Ram pick-up truck stolen from the 1100 Block of 16th Avenue on August 29th. Later that afternoon, the vehicle was located in the city of West Allis after a citizen called the West Allis Police Department and reported observing three juveniles park the truck and leave on foot. South Milwaukee investigators responded to the West Allis location to continue their investigation and the truck was returned to the owner. The investigation into this matter remains ongoing and anyone with information is encouraged to contact the South Milwaukee Police Department.

RETAIL THEFT

Officers were dispatched to a report of an individual leaving a store in the 200 Block of North Chicago Avenue without paying for merchandise on August 29th. Store employees detained a 48-year-old Milwaukee man after observing him take a backpack off a shelf and fill it with clothing items before leaving the store without paying for any of the items. The man was arrested and taken to the police department where he was issued a citation for Retail Theft.

Officers were dispatched to a report of an individual attempting to leave a store in the 200 Block of North Chicago Avenue without paying for a basketball on August 28th. Officers spoke with a 26-year-old Milwaukee man who had two basketballs. Store video showed the man, who entered the store with one basketball, take another basketball off the shelf and write on it before attempting to leave with both basketballs. He was arrested and taken to the police department where he was issued a citation for Retail Theft.

Officers were dispatched to a store in the 2900 Block of South Chicago Avenue on August 30th for a report of two individuals that had previously stolen items from the store and were attempting to steal items again. Officers spoke with a 28-year-old Milwaukee man and a 30-year-old Milwaukee woman outside the store. Both were in possession of drug paraphernalia and the woman had items from the store in her possession that were not paid for. Both were arrested and issued citations for Possession of Drug Paraphernalia and the woman was also issued a citation for Retail Theft.
