

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 9/2/19 – 9/8/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **260** calls for service.

DISORDERLY CONDUCT

On September 7th, officers were dispatched to a report of an individual pounding on an apartment door and hitting the windows of a vehicle in the 3400 Block of Marina Road. Upon arrival officers spoke with a 23-year-old Manitowoc woman and a 31-year-old South Milwaukee man. Both had been involved in an altercation earlier in the evening in the city of Milwaukee and the man stated the woman came to South Milwaukee to confront him. The woman, who was intoxicated, was argumentative with officers and refused to leave the area. She was arrested and brought to the police station where she was issued a citation for Disorderly Conduct.

A 37-year-old South Milwaukee woman reported two individuals had taken a ladder from her yard and were banging it against her residence in the 500 Block of Hawthorne Avenue during the overnight hours of September 7th. The woman also stated one of the subjects began to walk away with the ladder. Officers located a 22-year-old Cudahy man and a 24-year old Caledonia woman sitting next to the ladder near the roadway. Both were intoxicated and denied striking the house with the ladder but could not explain how the ladder came to be near them from the caller's residence. The man and the woman were issued citations for Disorderly Conduct.

Officers were dispatched to a report of an individual shouting in the 1300 Block of Columbia Avenue on September 7th. Officers located an intoxicated 34-year-old Cudahy woman in the area. A 45-year-old South Milwaukee man told officers he asked the woman to leave his residence and she refused. The woman was arrested and issued a citation for Disorderly Conduct.

HIT AND RUN ACCIDENT

On September 5th, officers were dispatched to a report of a motor vehicle accident in the 500 block of Southtowne Drive. Officers located a vehicle on its side, which appeared to have turned over after striking a large rock near a driveway. A witness stated a male driver and a female passenger exited the vehicle and the male driver left the scene on foot. An intoxicated 34-year-old Cudahy woman was on the scene and admitted to being the passenger in the vehicle. The owner of the vehicle reported a 36-year-old Milwaukee man borrowed his vehicle the previous night and had not returned it. The witness identified the Milwaukee man as the driver and officers issued him a citation for Hit and Run. The woman was issued citations for Obstructing and Disorderly Conduct.

On September 6th, a caller reported a vehicle struck a parked car and a house in the 1400 Block of Michigan Avenue and then fled the scene. Officers located a parked vehicle with damage and observed damage to the porch of a nearby residence. Officers also located parts from a Ford Fiesta on the scene. A short time later, Oak Creek police officers stopped a Ford Fiesta that had damage consistent with being in an accident. The driver, a 37-year-old Milwaukee woman, stated she had driven from South Milwaukee after becoming involved in a verbal argument with a 38-year-old South Milwaukee man. She was issued citations for Hit and Run and Failure to Keep a Vehicle Under Control.

VEHICLE THEFT

A citizen reported two individuals attempted to steal her motorcycle in the 800 Block of Sycamore Avenue on September 4th. When the caller confronted the subjects, they left in a vehicle. An officer attempted to stop the vehicle and it fled and a short pursuit was terminated. A short while later, officers were notified of an accident at Rawson and Nicholson Avenues involving the vehicle. A witness stated two subjects left the vehicle on foot. With assistance from officers from the St. Francis, Oak Creek, Cudahy, Greenfield, and Milwaukee Police Departments as well as deputies from the Milwaukee County Sheriff's Department, a 25-year-old Milwaukee man was located in a nearby wooded area. He along with an 18-year-old Milwaukee man who was identified as the driver will be referred to the Milwaukee County District Attorney's Office for charges.
