

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 9/16/19 – 9/22/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **305** calls for service.

### **WARRANT ARREST**

A citizen requested officers check on a male and female who appeared to be intoxicated and arguing in Grant Park on September 19<sup>th</sup>. The male party had left the scene prior to the arrival of officers and a 39-year-old Racine woman was located and arrested by Milwaukee County Sheriff's Department deputies for Public Intoxication. Later in the evening a citizen in the 500 Block of Lake Drive reported an unknown male was ringing his doorbell. Officers located a 39-year-old Racine man who fit the description of the male from the earlier call and was found to have a confirmed warrant with the Racine County Sheriff's Department. The man became uncooperative and was arrested. He was issued citations for Disorderly Conduct and Resisting Arrest before being taken to the Racine County Sheriff's Department on the warrant.

Officers were dispatched to the 1300 Block of Minnesota Avenue for a report of suspicious activity on September 17<sup>th</sup>. Officers spoke with a 34-year-old Champaign, Illinois man who was found to have two confirmed full extradition warrants with the Champaign County Sheriff's Office in Illinois. He was arrested and taken to the Milwaukee County Criminal Justice Facility to await extradition to Illinois.

An officer initiated a traffic stop on a vehicle with a defective headlamp in the 500 Block of Milwaukee Avenue on September 22<sup>nd</sup>. The driver, a 26-year-old Milwaukee man, did not have a driver's license and was found to have a confirmed warrant with the Racine County Sheriff's Department. He was arrested and issued a citation for Operating Without a License before being turned over to Racine County Sheriff's Department deputies on the warrant

### **OPERATING WHILE INTOXICATED**

An officer initiated a traffic stop on a vehicle traveling in the wrong lane of traffic in the 600 Block of Milwaukee Avenue on September 22<sup>nd</sup>. The driver, a 47-year-old South Milwaukee man, showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-6<sup>th</sup> Offense and Operating After Revocation.

An officer on patrol noticed a driver passed out behind the wheel of a parked vehicle in the 900 Block of Milwaukee Avenue on September 21<sup>st</sup>. The driver, a 27-year-old Racine woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-1<sup>st</sup> Offense and Operating With a Prohibited Blood-Alcohol Concentration before being released to a sober responsible adult.

### **DISORDERLY CONDUCT**

Officers were dispatched to a report of subjects arguing in the 1300 Block of Minnesota Avenue on September 17<sup>th</sup>. Officers spoke with a 33-year-old South Milwaukee man and a 35-year-old South Milwaukee woman who had been involved in a verbal argument. The man agreed to leave the area and officers cleared from the scene. A short while later, officers were called back to the area as the man had returned and was causing problems. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct.
