

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 9/23/19 – 10/6/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **480** calls for service.

### **DISORDERLY CONDUCT**

On September 27<sup>th</sup> an altercation occurred between several juveniles in the 2700 Block of South Chicago Avenue. On September 29<sup>th</sup>, officers were dispatched to the 2700 Block of South Chicago Avenue for a physical altercation involving the same juveniles. A 14-year old Cudahy girl, two 13-year-old South Milwaukee girls, along with a 20-year old Waukesha woman, and a 31-year-old Racine woman were all arrested and issued citations for Disorderly Conduct. A 17-year-old Oak Creek girl and a 13-year-old South Milwaukee boy were also arrested and issued citations for Battery.

Officers were dispatched to a report of a person refusing to leave a residence in the 1200 Block of Milwaukee Avenue on October 4<sup>th</sup>. Officers spoke with a 38-year-old South Milwaukee man who stated he asked a 34-year-old Cudahy woman to leave his residence after she created a disturbance. The woman, who was intoxicated, continued to use loud and profane language and refused to leave the residence. She was arrested and issued a citation for Disorderly Conduct.

**On September 29<sup>th</sup>, officers were dispatched to the 300 Block of Southtowne Drive for a report of an unknown man who appeared to be passed out in the hallway of a building. Officers located a 39-year-old South Milwaukee man who regained consciousness after officers arrived. The man, who appeared intoxicated and was in possession of a liquor bottle, was out on bail from a previous felony case with a condition of bail being absolute sobriety. He was arrested and issued a citation for Disorderly Conduct before being taken to the Milwaukee County Criminal Justice Facility for Felony Bail Jumping.**

### **WARRANT ARREST**

**On September 28<sup>th</sup>, officers were dispatched to a report of an individual who appeared to be passed out near North Chicago and Badger Avenues. Officers made contact with a subject who was awakened and identified as a 46-year-old Milwaukee man. The man was found to have a confirmed warrant with the Waukesha County Sheriff's Department. He was arrested on the warrant and taken to the police station before being turned over to deputies from the Waukesha County Sheriff's Department.**

**On October 5<sup>th</sup>, officers received information an individual with a felony warrant with the Wisconsin Department of Corrections was in the 1600 Block of Missouri Avenue. Officers located the individual, a 37-year-old South Milwaukee man and the felony warrant was confirmed. The man also had multiple municipal warrants with both the South Milwaukee and Cudahy Police Departments. The man was arrested without incident and taken to the Milwaukee County Criminal Justice Facility.**

### **RETAIL THEFT**

**On September 30<sup>th</sup>, officers were dispatched to a report of a man leaving a business in the 3100 Block of South Chicago Avenue without paying for items. Officers located a 30-year-old Oak Creek man who matched the description given, in the 2900 Block of South Chicago Avenue. The man was in possession of the items taken from the store and was out on bail for prior theft cases. He was arrested and issued a citation for Retail Theft-2<sup>nd</sup> Offense and referred to the Milwaukee County District Attorney's Office on a Bail Jumping charge.**
