

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 10/14/19 – 10/20/19**



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **295** calls for service.

### **TRESPASS**

On October 14<sup>th</sup>, officers were dispatched to a report of an individual trespassing on the property of a business in the 100 Block of Edgar Avenue. Officers spoke with the business owner and observed surveillance video showing a man entering the locked fenced-in gated rear yard of the business. The individual was identified as a 34-year-old Crystal Lake, Illinois man and he was issued a citation for Trespassing.

### **WARRANT ARREST**

On October 17<sup>th</sup>, an officer from the Oak Creek Police Department on a traffic stop near Drexel Boulevard and Sanctuary Drive reported the driver of the stopped vehicle held a confirmed warrant with the South Milwaukee Police Department. South Milwaukee officers arrived at the scene and arrested the driver, a 20-year-old Milwaukee man, on the warrant. The man was brought to the police station where he posted the required bond on the warrant and was released.

On October 20<sup>th</sup>, officers were dispatched to the 400 Block of Bay Heights Road for an individual acting disorderly. Officers spoke with a 49-year-old South Milwaukee man who arguing with other individuals. The man was found to have a confirmed warrant with Probation and Parole. He was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrant.

## **RETAIL THEFT**

On October 15<sup>th</sup>, officers were dispatched to a report of two individuals attempting to take merchandise from a business in the 200 Block of North Chicago Avenue without paying for it. Store security employees observed the individuals in the self-check-out scan lower priced items multiple times while placing higher priced items in their grocery bag. Officers spoke with a 31-year-old Milwaukee woman and a 28-year-old Milwaukee man and found their receipt did not match the items they had with them. Both were arrested and after originally providing false identification information, the man was positively identified and found to have a confirmed felony warrant with the Milwaukee Police Department. The woman was issued a citation for Retail Theft and the man was issued citations for Retail Theft, Possession of Marijuana, and Obstructing before being turned over to officers from the Milwaukee Police Department on the warrant.

On October 16<sup>th</sup>, officers were dispatched to a report of a man attempting to leave a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 54-year-old Cudahy man who had items from the store concealed in his jacket. The man had been banned from the store due to previous thefts and was also found to have a confirmed warrant with the Milwaukee County Sheriff's Department. The man was arrested and referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct (Trespassing) and Retail Theft. He was turned over to deputies from the Milwaukee County Sheriff's Department on the warrant.

## **OPERATING WHILE INTOXICATED**

On October 20<sup>th</sup>, an officer observed a vehicle cross the center line numerous times in the 2800 Block of South Chicago Avenue and a traffic stop was initiated near Forest Hill Avenue and Russet Lane. The driver, a 64-year-old Cudahy man, showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-Third Offense.
