

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 10/28/19 – 11/03/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **271** calls for service.

LAW ENFORCEMENT ASSISTANCE

An officer was returning from an assignment in Milwaukee On October 28TH and while in the city of Cudahy, was asked to assist officers from the Cudahy Police Department who were involved in a foot pursuit with an individual suspected of prowling. The officer went to the area of the incident and joined the foot pursuit after observing an individual who matched the description given run past him. The individual ignored several commands to stop and after a successful taser deployment was taken into custody. The individual was identified as a 24-year-old Milwaukee man and was found to have outstanding warrants. He was turned over to officers from the Cudahy Police Department.

DISORDERLY CONDUCT

On November 2nd, officers were dispatched to the 200 Block of North Chicago Avenue after a 19-year-old South Milwaukee man reported he was threatened by a man who was upset he left his car door open too long in the parking lot. Officers located the other man nearby and identified him as a 63-year-old Cudahy man. He was arrested and issued a citation for Disorderly Conduct after witnesses also stated they heard the man threaten the caller.

WARRANT ARREST

On October 29TH, officers were dispatched to the intersection of North Chicago Avenue and the Oak Creek Parkway for a vehicle crash involving two cars. No injuries were reported and officers spoke with a male and a female who were the drivers. The female originally provided false identification information and was eventually identified as a 29-year-old Oak Creek woman. She was found to have a confirmed warrant with the Milwaukee County Sheriff's Department. She was arrested on the warrant and turned over to deputies from the Milwaukee County Sheriff's Department. She was also issued citations for Obstructing, Operating After Suspension, and Failure to Yield the Right of Way.

On October 29th, an officer conducted a traffic stop on a vehicle without a registration sticker near South Chicago and Sherman Avenues. The driver, a 21-year-old Milwaukee woman was found to have a confirmed felony warrant with the Walworth County Sheriff's Department. She was arrested and taken to the Milwaukee County Criminal Justice Facility to be turned over to Walworth County Sheriff's Department on the warrant. She was also issued a citation for Operating While Suspended.

On November 3rd, an officer conducted a traffic stop on a vehicle with expired registration in the 1100 Block of Milwaukee Avenue. The driver, a 43-year-old Milwaukee man was found to have a confirmed felony warrant with the Milwaukee Police Department. He was arrested and taken to the police department where he was turned over to officers from the Milwaukee Police Department. He was also issued a citation for Operating While Suspended.

On November 1st, officers were dispatched to a report of a individuals attempting to leave a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 36-year-old Milwaukee woman and a 34-year-old Milwaukee man. After initially providing false identification information, the man was found to have a confirmed felony warrant with the Milwaukee Police Department as well as warrants with the Waukesha County Sheriff's Department, and the Milwaukee County Sheriff's Department. He was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrants.
