

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 12/2/19 – 12/8/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **246** calls for service.

### **DAMAGE TO PROPERTY**

On December 4<sup>th</sup>, officers were alerted to a damaged vehicle parked in the 500 Block of Madison Avenue. A 32-year-old South Milwaukee woman stated she was the primary driver of the vehicle that belonged to her friend and she suspected a 26-year-old South Milwaukee man caused the damage as she had located him in her garage earlier in the evening. The woman had an active No Contact Order against the man and personal items that identified him were located in the garage. The man was located near 6<sup>th</sup> and Michigan Avenues and he was arrested. He was taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Criminal Damage to Property, Burglary, Disorderly Conduct, and Bail Jumping.

### **RETAIL THEFT**

On December 2<sup>nd</sup>, an officer on patrol observed two individuals running out of a business in the 2900 Block of South Chicago Avenue followed by employees who indicated they had stolen merchandise. The officer was able to apprehend one of the subjects, a 29-year-old Milwaukee man, who admitted to taking energy drinks from the store. The other individual, a 30-year-old Milwaukee woman, was also located and it was determined she did not take any items. The man was arrested and taken to the police station where he was issued a citation for Retail Theft.

## **DISORDERLY CONDUCT**

On December 3<sup>rd</sup>, officers were dispatched to a residence in the 200 Block of North Chicago Avenue after a female caller locked in a bathroom reported being threatened by a male subject. Upon arrival officers received no answer at the door despite hearing individuals inside and a forced entry was made. Officers located the caller, a 24-year-old South Milwaukee woman and a 30-year-old South Milwaukee man was arrested and referred to the Milwaukee County District Attorney's Office on a domestic violence related charge of Disorderly Conduct. A 59-year-old South Milwaukee man and a 59-year-old South Milwaukee woman were also issued citations for Obstructing an Investigation.

On December 4<sup>th</sup>, officers were dispatched to a report of individuals arguing in a parking lot in the 3100 Block of South Chicago Avenue. Officers arrived on scene and determined the argument began near road construction at Forest Hill Avenue and Harmony Lane. A 17-year old St. Francis girl in a vehicle approached a construction worker holding a flag and attempted to drive around her. When advised to stop, the girl made an obscene gesture before driving off and the worker followed her to the parking lot. The girl was arrested and issued a citation for Disorderly Conduct.

On December 6<sup>th</sup>, officers were dispatched to a report of individuals fighting in the 200 Block of North Chicago Avenue. Officers spoke with a 20-year-old South Milwaukee woman who stated she was punched by an 18-year-old South Milwaukee woman. The 18-year-old woman admitted to being the primary instigator of the altercation and she was arrested and issued a citation for Disorderly Conduct.

## **OPERATING WHILE INTOXICATED**

On December 5<sup>th</sup>, an officer on patrol noticed a vehicle parked and running in the 2300 Block of 10<sup>th</sup> Avenue with a driver who appeared to be passed out. The officer also observed drug paraphernalia in the vehicle and the driver, a 31-year-old South Milwaukee man, was eventually woke up. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated and Possession of Drug Paraphernalia.
