

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 1/6/20 – 1/12/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **235** calls for service.

THEFT

On January 9TH, several citizens in the South-East section of the city reported items stolen from their vehicles. With the assistance of citizen-provided surveillance video a suspect was developed based on prior police contacts. Further investigation resulted in the obtaining of a search warrant for a residence in the city of Milwaukee and upon execution of the warrant, many of the stolen items were recovered. Officers arrested a 22-year-old Milwaukee man, a 19-year-old Milwaukee man, and a 15-year-old Milwaukee boy who were all referred to the Milwaukee County District Attorney's Office on Felony Theft charges.

DISORDERLY CONDUCT

On January 11th, officers were dispatched to a report of an intoxicated individual possibly in need of assistance in the 2400 Block of 15th Avenue. Officers spoke with a 33-year-old South Milwaukee man who was on Probation with a condition being absolute sobriety. The man became argumentative with officers and he was arrested. He was issued a citation for Disorderly Conduct before being taken to the Milwaukee County Criminal Justice Facility on the Probation and Parole hold.

On January 11th, officers were dispatched to a report of an unruly customer at a business in the 200 Block of North Chicago Avenue. Officers located a 50-year-old South Bend, Indiana woman who was yelling and refusing to leave the store. The woman, who initially refused to identify herself, continued to shout profanities and was arrested. She was taken to the police station where she was issued citations for Disorderly Conduct and Obstructing.

WARRANT ARREST

On January 7th, a caller reported an individual with a felony warrant was at a residence in the 500 Block of Michigan Avenue. Officers observed the individual, a 39-year-old South Milwaukee woman, leave the residence in a vehicle and a traffic stop was initiated. Officers located drug paraphernalia while speaking with the woman. A felony warrant with the Milwaukee County Sheriff's Office was confirmed and the woman was arrested. She was taken to the police station where she was issued a citation for Possession of Drug Paraphernalia before being turned over to deputies from the Milwaukee County Sheriff's Office.

On January 9th, officers were dispatched to a report of an individual acting disorderly in a residence in the 1200 Block of Missouri Avenue. Officers spoke with a 51-year-old South Milwaukee woman who was found to have a confirmed warrant with the Dane County Sheriff's Office. She was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrant.

On January 8th, a caller reported an individual with a warrant was inside a business in the 1100 Block of Milwaukee Avenue. Officers spoke with a 37-year-old South Milwaukee woman who was found to have a confirmed warrant with the Milwaukee County Sheriff's Office. The woman fled the business but was soon apprehended and arrested. She was taken to the police station where she was issued a citation for Resisting Police before being turned over to deputies from the Milwaukee County Sheriff's Office on the warrant.
