

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 1/20/20 – 1/26/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **260** calls for service.

SUSPICIOUS PERSON

On January 23RD, a caller from the 1300 Block of Milwaukee Avenue reported a recently evicted tenant and a suspect in numerous open retail theft investigations, continued to frequent the area. Officers responded and located a 31-year-old West Allis man near his parked vehicle. Drug paraphernalia was found inside the vehicle and the man was arrested. While at the police station, the man admitted his involvement in three retail theft cases. He was issued a citation for Possession of Drug Paraphernalia and referred to the Milwaukee County District Attorney's Office on the Retail Theft charges.

DISORDERLY CONDUCT

On January 25th, officers were dispatched to a report of individuals involved in an altercation in a parking lot in the 2300 Block of 10th Avenue. Officers spoke with a 25-year-old South Milwaukee man and a 44-year-old South Milwaukee man. An investigation revealed the 25-year-old man was a passenger in a vehicle performing a backing maneuver when the 44-year-old man honked the horn of his vehicle to avoid a possible collision. The 25-year old man exited the vehicle and confronted the 44-year-old man. The 25-year-old man was arrested and issued a citation for Disorderly Conduct.

ARREST WARRANT

On January 21st, officers were dispatched to a report of a male passed out inside a business in the 1000 Block of Milwaukee Avenue. Officers spoke with a 28-year-old South Milwaukee man who was intoxicated but had no other medical issues. The man was found to have a confirmed warrant with the Milwaukee County Sheriff's Office. He was arrested on the warrant and taken to the police station. The man was released after bail as posted at the police station by a friend.

On January 26th, an officer monitoring traffic initiated a vehicle stop in the 900 Block of Nicholson Avenue on a vehicle for a speeding violation. The driver, a 27-year-old Milwaukee man was found to have a suspended driver's license and a confirmed warrant with the Bayside Police Department. He was arrested and taken to the police station where he was issued a citation for Operating While Suspended. He was turned over to officers from the Bayside Police Department on the warrant.

RETAIL THEFT

On January 20th, officers were dispatched to a report of an individual leaving a business in the 2900 Block of South Chicago Avenue without paying for items. A citizen directed officers to a man in a nearby parking lot whose clothing did not fit the original description given. Officers spoke with the 53-year-old Milwaukee man and located a bag nearby containing items from the store that were not paid for along with clothing that matched the description given by employees. Drug paraphernalia was also found on the man and he was arrested. He was taken to the police station and issued citations for Retail Theft and Possession of Drug Paraphernalia.

On January 22nd, officers were dispatched to a report of an individual leaving a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 32-year-old Milwaukee man who was in possession of electric toothbrushes and batteries that were not paid for. The man had also been banned from the business due to a prior retail theft. He was arrested and issued citations for Retail Theft and Disorderly Conduct.
