# SOUTH MILWAUKEE POLICE DEPARTMENT

## WEEKLY CRIME SUMMARY 2/03/19 - 2/10/19

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past week the South Milwaukee Police Department responded to 272 calls for service.

#### **WARRANT ARREST**

A 30 year old Milwaukee woman was arrested on a confirmed warrant with the Racine County Sheriff's Department following a traffic stop in the 100 Block of North Chicago Avenue at 9:37 am on February 9<sup>th</sup>. The woman was a passenger in the vehicle and the driver, a 31 year old Milwaukee man, was issued citations for Operating After Suspension and Operating a Motor Vehicle Without Insurance. The woman was taken to the police station where she was later turned over to Racine County authorities.

A 23 year old Milwaukee man was arrested on two confirmed warrants with the Waukesha County Sheriff's Department following a traffic stop in the 1400 Block of College Avenue at 1:10 am on February 9<sup>th</sup>. The man was taken to the police station before being transported to the Waukesha County Jail.

Officers were dispatched to the 200 Block of North Chicago Avenue at 5:09 pm on February 8<sup>th</sup> for a report of a wanted individual who was known to have multiple warrants. The individual, a 33 year old South Milwaukee man, attempted to flee as officers arrived. After a brief struggle the man was arrested on a confirmed Probation/Parole warrant with the Dodge County Sheriff's Department and a confirmed Burglary warrant with the Waukesha County Sheriff's Department. He was taken to the police station where he was issued a citation for Resisting Arrest before being turned over to Waukesha County authorities.

#### **VEHICLE THEFT**

A resident in the 2400 Block of Nicholson Avenue reported his vehicle stolen just before 9:00 pm on February 7<sup>th</sup>. The resident reported his girlfriend allowed two unidentified individuals to use his vehicle to go to a store on February 4<sup>th</sup> and they had yet to return the vehicle. The vehicle is described as a silver four-door 2007 Ford Taurus with large dents on each passenger side door. An investigation is ongoing in an attempt to identify the individuals and locate the vehicle.

### **DISORDERLY CONDUCT**

Officers were dispatched to a report of a male and a female arguing in a vehicle parked in the 2900 Block of South Chicago Avenue at 10:49 pm on February 10<sup>th</sup>. Officers located a 20 year old Oak Creek woman and a 20 year old Milwaukee man who stated they were no longer arguing. An amount of marijuana was also located in the vehicle which the Oak Creek woman claimed was hers. She was arrested and taken to the police station where she was issued a citation for Possession of Marijuana.

At 2:44 pm on February 3<sup>rd</sup>, dispatchers from the Milwaukee County Sheriff's Office advised South Milwaukee dispatch of a 911 call they received coming from the area of the 500 Block of Southtowne Drive where a female caller made a statement about a gun before disconnecting the call. Officers were able to determine the apartment the call came from and made contact with a 23 year old South Milwaukee woman who stated she argued with a 27 year old South Milwaukee man and he had verbally threatened her earlier before leaving. No weapons were located and the incident was referred to the Milwaukee County District Attorney's Office seeking the charge of Disorderly Conduct-Domestic Violence Related against the man.
