

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 3/16/20 – 3/22/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **128** calls for service.

LAW ENFORCEMENT ASSISTANCE

On March 21st, officers received information from the Evanston, Illinois Police Department regarding an individual reported missing from their jurisdiction who was thought to be in South Milwaukee. Officers responded to the area of the 300 Block of Williams Avenue and located the individual, a 72-year-old Evanston, Illinois man, sitting inside his parked vehicle. The man spoke with officers and did not need medical attention. Officers were able to make contact with his family members who came to the police station to pick him up.

DISORDERLY CONDUCT

On March 18th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of a disorderly customer. Officers spoke with a man in the parking lot of the business who witnesses stated was inside the store using profanity and threatening customers. After initially refusing to provide identification, the man was eventually identified as a 58-year-old Milwaukee man. He was arrested and issued a citation for Disorderly Conduct.

On March 17th, officers were dispatched to a report of two individuals involved in an altercation in the 1100 Block of Milwaukee Avenue. Officers located a 21-year-old South Milwaukee man who had minor injuries consistent with being in a fight. The man denied medical attention and stated he fought with another man after being involved in an earlier argument. He was arrested and issued a citation for Disorderly Conduct. The other individual was identified as a 30-year-old South Milwaukee man and he was issued a citation for Disorderly Conduct as well.

On March 18th, officers were notified of a traffic complaint involving two individuals that occurred near the intersection of Hawthorne and North Chicago Avenues. A 55-year-old Racine woman reported a vehicle cut her off and she honked her vehicle's horn. The driver of the other vehicle then proceeded to aggressively apply the brakes in front of her while making an obscene gesture. The other driver, a 46-year-old South Milwaukee man, was argumentative and admitted to "brake checking" the woman while making the obscene gesture. He was issued a citation for Disorderly Conduct.

WARRANT ARREST

On March 19th, an officer was dispatched to a minor vehicle accident in the 3300 Block of South Chicago Avenue. One of the individuals involved, a 39-year-old West Allis man, was found to have a confirmed felony warrant with the Milwaukee Police Department. He was arrested and taken to the police station where he was turned over to officers from the Milwaukee Police Department.

OPERATING WHILE INTOXICATED

On March 16th, officers were dispatched to the intersection of Elm and Nicholson Avenues for a report of a vehicle running with a subject sleeping inside. Officers responded and were able to wake the driver, a 28-year-old Greenfield man, who showed signs of impairment. Drug paraphernalia was also located in the vehicle. The man was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-4th Offense and Operating After Revocation. He was also issued a citation for Possession of Drug Paraphernalia.
