

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 3/23/20 – 4/5/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **227** calls for service.

THEFT

On March 25th, officers were dispatched to a report of individuals arguing in an apartment in the 300 Block of Southtowne Drive. Officers spoke with a 20-year-old South Milwaukee woman who stated she was involved in an argument with a 22-year-old Milwaukee man. The woman stated during the course of the argument unknown friends of the Milwaukee man entered the apartment and took her television. The man and the others left in a black truck prior to the arrival of officers. Police are seeking the Milwaukee man who has been identified and the investigation is ongoing.

On April 5th, a 24-year-old South Milwaukee man reported items were taken from his parked vehicle in the 3600 Block of South Chicago Avenue. Earlier in the evening officers from the Oak Creek Police Department arrested a 39-year-old Oconomowoc man and a 26-year-old West Allis man for taking items from vehicles in Oak Creek. The two men were also in possession of items reported taken from the South Milwaukee man's vehicle. Both the Oconomowoc man and the West Allis man will be issued citations for Theft.

BATTERY

On March 26th, A 39-year-old Cudahy woman reported she was struck in the face by a plastic water bottle thrown by a 37-year-old South Milwaukee man in the 2300 Block of 10th Avenue. The woman and the man were involved in an argument when he threw the water bottle. The man left the scene prior to the arrival of officers. A warrant was issued for his arrest and the Milwaukee County District Attorney's Office charged him with Battery, Disorderly Conduct, and Bail Jumping.

DISORDERLY CONDUCT

On April 5th, a 39-year-old Milwaukee man delivering newspapers in the 2300 block of 10th Avenue reported a female in a vehicle displayed a weapon towards him. Officers located the vehicle and initiated a traffic stop in the 2100 Block of 10th Avenue. Officers had a 42-year-old Milwaukee woman, a 40-year-old Milwaukee woman, and a 15-year-old Milwaukee boy exit the vehicle and located a firearm inside. The firearm belonged to the 42-year-old woman and she was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct While Armed.

On April 2nd, officers were dispatched to the 400 Block of North Chicago Avenue for a report of an individual becoming combative with medical personnel. Officers spoke with a 29-year-old Oak Creek woman who appeared to be under the influence of a controlled substance. She was eventually tended to by medical personnel and no further medical attention was deemed necessary. She was issued a citation for Disorderly Conduct after being cleared by medical personnel on the scene.

HEALTH ORDER VIOLATION

On April 4th, officers were dispatched to a report of a group of individuals gathering for a party inside a business in the 1400 Block of Rawson Avenue. Officers located six individuals eating food and consuming alcohol inside the establishment. All the individuals left without incident when advised of the health order. The owner of the business, a 63-year-old South Milwaukee man was issued a citation for Violation of a Health Order.
