

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 8/24/20 – 9/6/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **507** calls for service.

BATTERY

On August 30th, officers were dispatched to a group of individuals arguing in the 1200 Block of Marquette Avenue. Officers spoke with numerous individuals and determined a 27-year old South Milwaukee man was refusing to leave a residence and was struck by a 42-year-old Waukegan, Illinois man. The Illinois man was issued a citation for Battery and the South Milwaukee man was issued a citation for Disorderly Conduct.

On August 31ST, officers were dispatched to a report of an altercation at a residence in the 1500 Block of Manitoba Avenue. Officers spoke with a 40-year-old Milwaukee woman who stated that while in the process of moving out of the residence, she was struck several times by a 59-year-old South Milwaukee woman. The 59-year-old woman admitted to hitting the 27-year-old woman and she was issued a citation for Battery.

On August 28th, officers were dispatched to the 500 Block of Marshall Avenue for a report of an individual damaging property. Officers spoke with a 51-year-old South Milwaukee man who stated a 29-year-old South Milwaukee man damaged property and struck him. Officers observed broken windows and a damaged television. The 29-year-old man was arrested and issued citation a citation for Possession of Drug Paraphernalia after drug paraphernalia was also located in the residence. The man was also referred to the Milwaukee County District Attorney's Office on charges of Domestic Violence Battery and Criminal Damage to Property.

DISORDERLY CONDUCT

On September 6th, officers were dispatched to a noise complaint regarding loud music at a residence in the 2400 Block of Nicholson Avenue. Upon arrival officers could hear the music from outside the residence. Officers spoke with the resident who refused to identify himself and refused to turn the music down. The resident, later identified as a 25-year-old South Milwaukee man, began to shout profanities towards officers in the presence of several witnesses including children. He was issued citations for Disorderly Conduct, Unnecessary Noise, and Obstructing.

On August 27th, officers were dispatched to a report of an argument at a business in the 1400 Block of Rawson Avenue. Officers spoke with a 50-year-old Montello man who stated a 33-year-old South Milwaukee woman took an identification lanyard off his neck during the argument. The South Milwaukee woman stated the man was asked to leave the business but later returned and she took the lanyard after he began taking photographs inside the business. Surveillance video showed the woman take the lanyard without permission and she was issued a citation for Disorderly Conduct. The man was advised he was no longer allowed inside the business.

RETAIL THEFT

On September 3rd, officers were dispatched to a report of individuals attempting to leave a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 37-year-old Milwaukee woman and a 24-year-old Milwaukee woman who were speaking with store security. Surveillance video showed the women failed to scan multiple items during the checkout process. The items were recovered and the women received citations for Retail Theft.

OPERATING WHILE INTOXICATED

On August 27th, an officer on patrol located a vehicle that struck a pole near Nicholson and Milwaukee Avenues. The driver, a 47-year-old South Milwaukee man, showed signs of impairment. He was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-4th Offense. He was also issued citations for Operating After Revocation and Failure to Keep Vehicle Under Control.
