

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 11/30/20 – 12/13/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **427** calls for service.

DISORDERLY CONDUCT

On December 9th, officers were dispatched to the 300 Block of Nicholson Avenue for a report of an individual acting disorderly and punching holes in the walls of a residence. Officers spoke with a 36-year-old South Milwaukee man who showed signs of impairment and was uncooperative with officers. The man was found to be out on bail for previous felony charges with a condition of the bail being absolute sobriety. The man was arrested and taken to the police station. The man was taken to the Milwaukee County Criminal Justice Facility after being medically cleared and will be referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct-Domestic Violence Related, Resisting Arrest, and Felony Bail Jumping.

On December 3rd, officers were dispatched to the 1500 Block of Marion Avenue for a report of an individual acting disorderly and threatening the person who called the police. Officers spoke with a 60-year-old South Milwaukee woman who stated a 27-year-old South Milwaukee man threatened her and she was concerned for the welfare of an infant child in the residence. Officers spoke with the South Milwaukee man who was uncooperative and would not leave the residence. The man was also in possession of a drug pipe. He was eventually arrested and issued citations for Disorderly Conduct and Possession of Drug Paraphernalia.

WARRANT ARREST

On December 10th, officers were dispatched to the 1400 Block of Rawson Avenue for a report of a woman screaming. Officers located a 48-year-old South Milwaukee woman who was intoxicated and stated she was yelling loudly for her friends. The woman was found to have a confirmed warrant with the Oconomowoc Police Department and she was arrested on the warrant. She was taken to the police station where the bond amount on the warrant was paid and she was released to a sober responsible adult.

On December 12th, officers were dispatched to the 3600 Block of 9th Avenue for a report of an individual refusing to leave a residence. Officers spoke with a 58-year-old South Milwaukee man and a 56-year-old South Milwaukee woman who both stated a 41-year-old West Allis woman was causing problems and would not leave the residence. The West Allis woman was also found to have confirmed warrants with multiple jurisdictions including the Waukesha County Sheriff's Office. She was arrested on the warrants and turned over to deputies from the Waukesha County Sheriff's Office.

RETAIL THEFT

On December 9th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of a subject who attempted to leave without paying for items. Officers spoke with a 42-year-old Milwaukee woman who was being detained by store security after attempting to leave without paying for a bottle of alcohol. The woman admitted to not paying for the alcohol and she was arrested. She was also found to have been banned from the business due to prior retail thefts. The woman was arrested and issued citations for Retail Theft and Trespassing.

FRAUD

On December 2nd, an individual from Oakland, New Jersey called and stated he received notification of items he did not purchase being available for pick up at a business in the 200 Block of North Chicago Avenue. The caller's credit card information was fraudulently used to place the order. Officers responded to the business at the time of pick up and spoke with a 20-year-old Milwaukee man who stated he sent there by a friend who was not the original caller. The man was arrested and referred to the Milwaukee County District Attorney's Office on a Theft charge.
