

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 1/25/21 – 2/7/21



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **432** calls for service.

LIQUOR VIOLATION

On February 1st, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of an individual who appeared to be passed out on a bench. Officers and South Milwaukee Fire Department personnel spoke with a 29-year-old Oak Creek woman who was in an incoherent state. A cup containing an intoxicating beverage was located next to the bench and the woman admitted to drinking from it. She was also found to be on Probation for prior alcohol related offenses. She was issued a citation for Open Intoxicants on the Street and was transported by South Milwaukee Fire Department personnel to the hospital.

WARRANT ARREST

On February 5th, an officer on patrol initiated a traffic stop on a vehicle operating with a defective headlamp in the 1100 Block of College Avenue. The driver, a 46-year-old West Allis man, did not have a valid license and was found to have a confirmed warrant with the West Allis Police Department for multiple unpaid citations. He was issued citations for Operating After Suspension and Operating Without Insurance and given a verbal warning on the defective headlamp. He was given a court date and released on a signed Personal Recognizance Bond on the West Allis warrant.

DISORDERLY CONDUCT

On January 29th, officers were dispatched to the 1800 Block of 15th Avenue after two citizens reported a man wearing a green coat threatened them with a knife. Officers located a 33-year-old South Milwaukee man who matched the description given in the 1500 Block of Rawson Avenue. The man admitted to the confrontation with the citizens and he was arrested. While searching the man, officers located multiple knives in his possession. The man was referred to the Milwaukee County District Attorney's Office where he was charged with Disorderly Conduct-Use of a Dangerous Weapon.

OPERATING WHILE INTOXICATED

On January 29th, an officer on patrol initiated a traffic stop on a vehicle near College Avenue and Holly Lane after the registered owner of the vehicle showed a revoked driving status. The driver and owner, a 29-year old Milwaukee man, showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-2nd Offense, Operating After Revocation, and Failure To Install an Ignition Interlock Device. The man was released to a sober, responsible adult.

On January 29th, officers were dispatched to the 1600 Block of Milwaukee Avenue for a report of a vehicle at a stop sign with the driver slumped over. Officers made contact with the driver, a 35-year-old South Milwaukee woman, who showed signs of impairment. A recently used can of insect repellent and prescription drugs were located in the vehicle and a strong chemical odor was present. She was arrested and referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-2nd Offense and Operating After Revocation.

RETAIL THEFT

On January 30th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for an individual leaving without paying for items. Officers spoke with a 32-year-old Milwaukee woman who concealed merchandise in a backpack and attempted to leave without paying for the items. She was arrested and issued a citation for Retail Theft.
