

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 5/3/21 – 5/16/21



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **438** calls for service.

DAMAGE TO PROPERTY

On May 15th, officers were dispatched to the 400 Block of Southtowne Place for a criminal damage report. A 23-year-old South Milwaukee woman reported tires were slashed and windows were broken on her parked vehicle. The woman had been involved in an argument via text message with a 26-year-old Milwaukee woman and a 22-year-old Milwaukee woman. The Milwaukee women claimed responsibility via text message and were issued citations for Criminal Damage to Property.

UNNECESSARY NOISE

On May 13th, an officer was dispatched to the 3300 Block of 5th Avenue for a report of loud music coming from a residence. Officers heard loud music on arrival and found the resident, a 60-year-old South Milwaukee man, was not at home. Officers spoke to the man by phone and he admitted turning on the music prior to leaving. The man had been warned previously on having music on loud and he was issued a citation for Unnecessary Noise.

DISORDERLY CONDUCT

On May 9th, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of an individual refusing to leave a business. Officers spoke with a 47-year-old Milwaukee man and advised him he was no longer welcome at the business. The man refused to leave and became uncooperative. He was arrested and issued citations for Disorderly Conduct and Resisting Arrest.

On April 30th, employees of a business reported being threatened by an individual who had been previously banned from the property for prior thefts. The employees reported a 31-year-old Cudahy man threatened them and threw items after being told to leave. Officers viewed surveillance video that showed the man throwing the items and he was issued a citation for Disorderly Conduct.

RETAIL THEFT

On May 16th, officers were dispatched to a business in the 2900 Block of South Chicago for a report of an individual leaving without paying for steaks and Tide pods. Officers located a 37-year-old Milwaukee man matching the description aboard a nearby Milwaukee Transit bus. The man was in possession of the items reported to be taken and showed officers a receipt. The items on the receipt did not match the items the man was in possession of and he was arrested. He was issued a citation for Retail Theft.

On May 14th, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of individuals attempting to leave the store without paying for items. Officers spoke with a 27-year-old West Bend woman and a 15-year-old Oak Creek boy who admitted to taking food items and candy. Both were issued citations for Retail Theft.

OPERATING WHILE INTOXICATED

On May 14th, officers were dispatched to the 600 Block of College Avenue for a report of a driver weaving in traffic and nearly striking pedestrians. Officers located the vehicle in the 700 Block of St. Sylvester Drive and spoke with the driver, a 22-year-old South Milwaukee woman. The woman showed signs of impairment and she was arrested. She was issued citations for Operating While Intoxicated-First Offense, Operating with a Prohibited Blood Alcohol Concentration, and Improper Turn. The woman was released to a sober, responsible adult.
