

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 5/31/21 – 6/13/21



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **433** calls for service.

BATTERY

On June 7th, officers were dispatched to the 400 Block of Southtowne Place for a report of an argument between two individuals. Officers located a 26-year-old South Milwaukee man on the scene and observed signs of an altercation. The man claimed to have been arguing with a 23-year-old South Milwaukee woman who left prior to the arrival of officers. The woman was located in the city of Oak Creek and claimed the man hit and choked her during the altercation. The man was arrested and referred to the Milwaukee County District Attorney's Office on charges of Domestic Violence Battery, Strangulation, and Disorderly Conduct.

DISORDERLY CONDUCT

On June 6th, officers were dispatched to the 1800 Block of 16th Avenue for a noise complaint involving individuals doing yardwork. Upon arrival, officers spoke with a 55-year-old Milwaukee man while a second male subject fled the area. The 55-year-old man was warned on the complaint and officers located the second individual, identified as a 33-year-old Milwaukee man, in a nearby dumpster. He was arrested and issued a citation for Resisting/Obstructing an Officer.

On June 10th, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of an individual passed out near a building. Officers responded and woke up a 30-year-old South Milwaukee man who was intoxicated. The man admitted to drinking from an empty liquor bottle found nearby and became uncooperative, refusing to identify himself or provide his address. He was arrested and taken to the police station where he was issued citations for Disorderly Conduct and Possession of Intoxicants in the street.

WARRANT ARREST

On June 11th, officers were dispatched to the 1200 Block of Milwaukee Avenue for a welfare check on an individual stumbling while walking. Officers spoke with a 33-year-old Milwaukee man who stated he was working outside in the heat and did not stay hydrated. He declined medical attention and was provided water. He was found to have a confirmed warrant with the Waukesha County Sheriff's Department. The man posted bail on the warrant.

On June 4th, an officer on patrol initiated a traffic stop on a vehicle with a defective headlamp in the 900 Block of Milwaukee Avenue. The driver, a 57-year-old Cudahy woman, had a revoked driving status and was found to have a confirmed felony warrant with the Waukesha County Sheriff's Department and a confirmed municipal warrant with the Hartland Police Department. She was arrested and issued a citation for Operating After Revocation before being turned over to deputies from the Waukesha County Sheriff's Department on the warrant.

DRUG INVESTIGATION

On June 12th, Officers were dispatched to the 1700 Block of Rawson Avenue for a report of an individual asleep inside a parked vehicle. Officers spoke with a 24-year-old Kenosha man who woke up upon the arrival of officers. The man was sweating profusely and South Milwaukee Fire Department paramedics responded to the scene. The man was found to have a confirmed warrant with Probation and Parole and the vehicle was reported stolen with the Greenfield Police Department. Numerous illegal drugs and drug paraphernalia were also located inside the vehicle. The man was arrested and taken to the hospital for evaluation. The man was issued citations for Possession of Marijuana and Possession of Drug Paraphernalia-Cocaine and Heroin. He was referred to the Milwaukee County District Attorney's Office on charges of Possession of Methamphetamine, Possession of Fentanyl, and Possession of Heroin. The vehicle was turned over to officers from the Greenfield Police Department.
