

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 6/28/21 – 7/11/21***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **449** calls for service.

### **ROBBERY**

On July 2<sup>ND</sup>, officers were dispatched to a report of a single actor who attempted to rob two businesses in the 2900 Block of South Chicago Avenue. The subject implied a weapon at both robberies but no weapon was observed. The subject obtained money from one of the businesses and fled the scene prior to officer arrival. An investigation resulted in the arrest of a 65-year-old South Milwaukee man. The man admitted to taking money from one of the businesses. He was taken to the Milwaukee County Criminal Justice Facility and charged by the Milwaukee County District Attorney's Office with Robbery, Attempted Robbery, and two counts of Bail Jumping.

### **DISORDERLY CONDUCT**

On July 1<sup>ST</sup>, officers were dispatched to the 1400 Block of Rawson Avenue for a report of a disturbance among individuals inside a business. Officers spoke with a 51-year-old South Milwaukee man who was involved in a verbal altercation with a 32-year-old South Milwaukee man and a 34-year-old South Milwaukee man. Officers spoke with witnesses and observed surveillance video which showed the 51-year-old man as the primary aggressor in the incident. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

## **THEFT**

On July 6<sup>th</sup>, officers were dispatched to the 2400 Block of South Chicago Avenue for a report of a wheel being taken from a vehicle. Officers viewed surveillance video that showed a male subject remove the wheel from a parked vehicle. Following an investigation, officers were able to identify the male subject as a 44-year-old Milwaukee man. The man came to the police station with the wheel and admitted to taking it. He was issued citations for Theft and Trespassing. The wheel was returned to the caller.

## **OPERATING WHILE INTOXICATED**

On July 4<sup>th</sup>, a citizen reported an intoxicated individual drove away recklessly from a business in the 2300 Block of 10<sup>th</sup> Avenue. Officers located the vehicle in the 500 Block of Madison Avenue and spoke with the driver, a 34-year-old South Milwaukee man. The man displayed signs of impairment and surveillance video from the video showed him driving the vehicle. He was arrested and referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-3<sup>rd</sup> Offense and Operating With a Prohibited Blood-Alcohol Concentration-3<sup>rd</sup> Offense.

On July 8<sup>th</sup>, an officer on patrol observed a vehicle deviate from the lane of travel and almost strike a curb in the 3100 Block of South Chicago Avenue. A traffic stop was initiated in the 2500 Block of South Chicago Avenue. The driver, a 22-year-old St. Francis man, showed signs of impairment. He was arrested and issued citations for Operating While Intoxicated-First Offense, Operating With a Prohibited Blood-Alcohol Concentration-First Offense, and Deviation from Designated Lane. He was released to a sober, responsible adult.

## **RETAIL THEFT**

On July 8<sup>th</sup>, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of two individuals attempting to take liquor bottles without paying for them. Officers located two 15-year-old South Milwaukee boys who attempted to flee the area. Both were apprehended and the liquor bottles were recovered. Both boys were arrested and taken to the police station. Both were issued citations for Retail Theft, Resisting, and Underage Possession of Alcohol. One boy was also issued a citation for Underage Possession of Tobacco Products after he was found to be in possession of a vaping device.
