

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 7/12/21 – 7/25/21



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **467** calls for service.

DISORDERLY CONDUCT

On July 21ST, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of an altercation between two individuals. Officers spoke with an 18-year-old South Milwaukee man who stated a 20-year-old Cudahy man grabbed him around the neck while he was inside a nearby business, which prompted the altercation. The Cudahy man stated he confronted the South Milwaukee man over social media posts regarding a friend of his. The Cudahy man was arrested and issued a citation for Disorderly Conduct.

On July 24th, officers were dispatched to the 1100 Block of Milwaukee Avenue for a report of an intoxicated individual acting disorderly. The caller reported a man became belligerent and shouted vulgarities when he was refused service due to his level of intoxication. Officers located the man nearby. The man originally provided false identification information and became uncooperative. He was eventually identified as a 32-year-old Milwaukee man and was arrested and issued citations for Disorderly Conduct and Resisting/Obstructing an Officer.

On July 20th, officers were dispatched to the 200 Block of North Chicago Avenue for a report of individuals involved in an altercation on a Milwaukee County Transit bus. Officers spoke with a 39-year-old South Milwaukee man and a 17-year-old Cudahy boy who were involved in the altercation after the man made derogatory comments toward a 17-year-old South Milwaukee girl. Both the South Milwaukee man and the Cudahy boy were arrested and issued citations for Disorderly Conduct.

OPERATING WHILE INTOXICATED

On July 17TH, an officer on patrol noticed an occupied vehicle illegally parked in the 100 Block of North Chicago Avenue with an odor of marijuana emanating from it. The vehicle drove away as the officer arrived and a traffic stop was conducted near 11th and College Avenues. The driver, a 36-year-old Milwaukee man, showed signs of impairment. Drug paraphernalia and an open liquor bottle were located in the vehicle and the man was in possession of marijuana and pills later identified as MDMA and Fentanyl. He was arrested and issued citations for Operating While Intoxicated-First Offense, Operating With a Prohibited Blood-Alcohol Concentration, Open Intoxicants, and Possession of Marijuana. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of possession of Fentanyl.

WARRANT ARREST

On July 19TH, an officer was dispatched to the 800 Block of Blake Avenue for a parking complaint regarding a parked car blocking a mailbox. The officer located a 29-year-old South Milwaukee man who was the owner of the parked vehicle. The man was found to have two confirmed warrants with the Milwaukee County Sheriff's Office for Theft and Burglary. He was arrested and taken to the police station where he was turned over to Milwaukee County Sheriff's deputies on the warrants.

On July 19th, officers were dispatched to the area of Rawson and Nicholson Avenues for a vehicle that had run out of gas. Officers spoke a 33-year-old Cudahy woman who was the driver of the vehicle. The woman was found to have a confirmed warrant for a South Milwaukee Police citation. She was arrested and taken to the police station where she was able to make a partial payment on the citation. She was issued a personal recognizance bond with a court date on the remaining balance.

RETAIL THEFT

On July 17th, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of a woman leaving a business without paying for bags of chips. Officers located the woman on a nearby Milwaukee County Transit bus and she was in possession of the chips but did not have a receipt for them. After initially providing false identifying information, she was identified as a 34-year-old Milwaukee woman. She was also in possession of drug paraphernalia and had a confirmed warrant with Probation and Parole. She was arrested and issued citations for Retail Theft, Obstructing, and Possession of Drug Paraphernalia. She was taken to the Milwaukee County Criminal Justice Facility on the warrant.
