

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 8/9/21 – 8/22/21



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **479** calls for service.

RECKLESSLY ENDANGERING SAFETY

On August 22ND, officers were dispatched to the area of 6th and Milwaukee Avenues for a report of a person possibly struck by a vehicle. Officers located a vehicle against a stone wall near a residence in the 500 Block of Milwaukee Avenue. A 26-year-old Racine man on the scene stated he attempted to exit the vehicle from the rear seat when the driver, a 31-year-old Kenosha man, grabbed onto him as the vehicle moved, causing him to fall and the vehicle to crash into the wall. Both men showed signs of impairment and the Racine man was in possession of drug paraphernalia. The Kenosha man was found to have open felony cases for robbery, possession of cocaine, and bail jumping. A 22-year-old Sheboygan woman who was a passenger in the vehicle was found to be in possession of drug paraphernalia and marijuana. All were arrested. The Racine man was issued a citation for Possession of Drug Paraphernalia and the Sheboygan woman was issued citations for Possession of Drug Paraphernalia and Possession of Marijuana. The Kenosha man was taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-Causing Injury, and two counts of Felony Bail Jumping.

DRUG INVESTIGATION

On August 18h, an officer on patrol noticed a vehicle driving without brake lights and a traffic stop was initiated in the 1000 Block of Milwaukee Avenue. The vehicle was driven by a 43-year-old South Milwaukee man and a 29-year-old Oak Creek man was a passenger. Drug paraphernalia was located inside the vehicle and inside a backpack belonging to the Oak Creek man. Both men admitted to ownership of the drug paraphernalia. Both were arrested. The South Milwaukee man was issued citations for Possession of Drug Paraphernalia-Heroin and Cocaine and Defective Stop Lights while the Oak Creek man was issued a citation for Possession of Drug Paraphernalia-Heroin.

DISORDERLY CONDUCT

On August 12th, officers were dispatched to the 1400 Block of Willow Lane for a report of a male subject arguing with a female and displaying a firearm. Officers located a 37-year-old South Milwaukee man and a 38-year-old South Milwaukee woman who were involved in an argument. The man was in possession of a firearm and he was arrested without incident. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct While Armed-Domestic Violence Related.

On August 9th, officers were dispatched to the 1300 Block of Rawson Avenue for a report of individuals arguing. Officers spoke with a 33-year-old Milwaukee woman who stated a 39-year-old Cudahy woman cut her off in traffic and began waving a knife-like object. A small exacto knife was located in the Cudahy woman's vehicle. The Cudahy woman stated both women were an acquaintance of a 41-year-old South Milwaukee man and had gone to the area for the purpose of a confrontation. Both women were issued citations for Disorderly Conduct.

On August 20th, officers were dispatched to the 2800 Block of South Chicago Avenue for a report of a disturbance between two individuals. Officers spoke with a 63-year-old South Milwaukee woman who stated a 37-year-old South Milwaukee man was threatening her and broke her computer tablet. The man was arrested and taken to the Milwaukee County Criminal Justice Facility and was referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence Related.

STOLEN VEHICLE RECOVERY

On August 17th, an officer on patrol noticed a parked vehicle with license plates that did not match the make or model of the vehicle. When the officer checked the Vehicle Identification Number, the vehicle was found to be reported stolen with the Milwaukee Police Department. The Milwaukee Police Department was notified and the vehicle was towed. The vehicle's owner, a 61-year-old Franklin woman, was contacted and given advice on retrieving the vehicle. The investigation along with identification paperwork located inside the vehicle was turned over to the Milwaukee Police Department.
