

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 4/6/20 – 4/19/20***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **220** calls for service.

### **DISORDERLY CONDUCT**

On April 7<sup>th</sup>, officers were dispatched to a report of individuals involved in an altercation in the 200 Block of North Chicago Avenue. Officers located a 40-year-old Milwaukee man and a 25-year-old Watertown man involved in a confrontation with a 48-year-old Cudahy man. The Cudahy man stated the other two men began to harass him in local businesses after all three exited a bus. All three were warned on their behavior and advised to leave the area. The Milwaukee man and the Watertown man were both intoxicated and continued to yell profanities while refusing to leave. Both were arrested and taken to the police station where they were issued citations for Disorderly Conduct. The Watertown man was also cited for Criminal Damage to Property after he intentionally caused damage to a jail cell.

On April 15<sup>th</sup>, officers were dispatched to a report of an altercation occurring in the 2000 Block of 10<sup>th</sup> Avenue between two individuals. Officers spoke with a 53-year-old South Milwaukee woman and a 27-year-old South Milwaukee woman who were involved in an argument. During the argument the 27-year-old woman threatened the 53-year-old woman and she was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence related.

## **RETAIL THEFT**

On April 9<sup>th</sup>, an officer on patrol was alerted by employees of a retail theft in progress in the 200 Block of North Chicago Avenue. The officer observed the individuals leave the area in a vehicle with the trunk open and the stolen merchandise inside. The officer was able to stop the vehicle in the 300 Block of North Chicago Avenue and other officers arrived on scene. Three Milwaukee women between the ages of 25 and 26 years old were arrested and issued citations for Retail Theft.

## **BATTERY**

On April 14<sup>th</sup>, officers were dispatched to a report of an unwanted person at a residence in the 500 Block of Madison Avenue. Officers spoke with a 33-year-old South Milwaukee woman who stated a 26-year-old South Milwaukee man came to the residence in violation of a No Contact Order and choked her before leaving the area. The man was located in the 700 Block of Michigan Avenue and he was arrested. He was charged by the Milwaukee County District Attorney's Office with Strangulation-Domestic Violence Related, Battery-Domestic Violence Related, Disorderly Conduct-Domestic Violence Related, and Bail Jumping.

## **OPERATING WHILE INTOXICATED**

On April 19<sup>th</sup>, officers were dispatched to a report of a vehicle parked and running with an unresponsive driver in the 3300 Block of Marina Road. Officers located the vehicle and a 51-year old Milwaukee woman who appeared to be suffering from an overdose. Drug paraphernalia was also visible in the vehicle. Officers were able to wake the woman using Narcan and South Milwaukee Fire Department personnel responded to the scene. The woman was taken to the hospital where she admitted to using heroin. She was issued citations for Operating While Intoxicated-Drug Related and Possession of Drug Paraphernalia.
