

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 5/18/20 – 5/31/20



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **406** calls for service.

DISORDERLY CONDUCT

On May 22nd, officers were dispatched to a report of an argument between individuals in the 1700 Block of Michigan Avenue. Officers spoke with a 58-year old South Milwaukee man and a 41-year-old South Milwaukee woman and both were advised to avoid contact with each other. The woman continued to yell loudly at both the man and officers and she was issued a citation for Disorderly Conduct.

On May 25th, officers were dispatched to a report of two men throwing bottles in the street after being involved in an altercation in the 1100 Block of Milwaukee Avenue. Officers located broken glass in the street and spoke with a 24-year-old Oak Creek man and a 29-year-old Milwaukee man who matched the description given. Both men stated they had been involved in the reported altercation with other unknown individuals but denied throwing bottles. They were issued citations for Disorderly Conduct and an investigation is ongoing as officers attempt to identify the other individuals involved.

On May 24th, officers were dispatched to a threat complaint in the 1900 Block of 13th Avenue. While taking the complaint, a 33-year-old South Milwaukee woman who was accused of making the threat, arrived at the scene and began yelling and using profanity. The woman continued to be uncooperative and she was arrested and issued citations for Disorderly Conduct and Resisting Arrest.

On May 24th, officers were dispatched to a report of a man threatening patrons and refusing to leave an establishment in the 1100 Block of Milwaukee Avenue. Officers spoke with a 40-year-old South Milwaukee man who became belligerent and refused to leave the business. The man was also in possession of a marijuana pipe. He was arrested and issued citations for Disorderly Conduct and Possession of Drug Paraphernalia.

OPERATING WHILE INTOXICATED

On May 28th, officers were dispatched to a report of a parked vehicle being struck at the intersection of Nicholson and Milwaukee Avenues. Callers also reported the driver of the striking vehicle appeared to be slumped over in his seat before driving away from the scene. Officers located the vehicle and conducted a traffic stop in the 1200 Block of Milwaukee Avenue. The driver, a 25-year-old South Milwaukee man, showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility and was referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated and Hit and Run Unattended Vehicle.

On May 30th, officers were dispatched to a report of a vehicle swerving into oncoming traffic near South Chicago and Forest Hill Avenues. Officers located the vehicle in the 800 Block of Marquette Avenue. The driver, a 46-year-old South Milwaukee man, was observed exiting the vehicle and running away from the scene. Officers spoke with him and he showed signs of impairment. An open beer can and marijuana was located in the vehicle. The man requested an ambulance and South Milwaukee Fire Department personnel arrived to transport the man to the hospital. After being medically cleared the man was arrested and taken to the Milwaukee County Criminal Justice Facility and was referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-4th Offense, Resisting Arrest, and Possession of Marijuana.
