NOTICE TO CONTRACTORS
LAKEVIEW AVENUE CONCRETE PAVEMENT**

Notice is hereby given that sealed proposals will be received in the office of the City Clerk of the City of South Milwaukee at the Administration Building, 2424 15th Avenue, South Milwaukee, WI 53172 **until 11:00 a.m. on Tuesday June 18, 2019**, at which time they will be publicly opened and read for the above public works improvement contract which will include rehabilitation of Lakeview Avenue (Harmony to Russet) with the following items of work:

- Concrete Pavement (8") 4,100 S.Y.
- Curb & Gutter 100 L.F.
- Concrete Sidewalk & Curb Ramp 200 S.F.
- Quantities of driveway approach, unclassified excavation, base aggregate, and lawn restoration.

The document set describes items and quantities for bid proposal. It is anticipated that a contract will be awarded by the South Milwaukee Common Council on June 18, 2019 and the work shall be complete by August 30, 2019 (prior to start of school).

Document sets for bidding must be obtained from Quest. There is a non-refundable fee of forty (\$40) dollars per set.

Prequalification forms for 2019 are required to be on file in the Office of the City Engineer for all contractors and subcontractors at least five days prior to bid opening. The Common Council's decision as to qualification shall be final.

Proposal must be placed in a sealed opaque envelope addressed to: **“City Clerk, City of South Milwaukee, Wisconsin” and marked “Proposal for Lakeview Avenue Concrete Pavement.”** If the bid is sent by mail, the sealed envelope shall be enclosed in a separate mailing envelope with the notation **“Sealed Bid Enclosed”** on the face thereof.

The City of South Milwaukee reserves the right to reject any or all bids and waive any informalities in the bidding. No bids shall be withdrawn after the opening of the bids without the consent of the City of South Milwaukee, Wisconsin, for a period of thirty (30) days after the scheduled time for closing bids.

All proposals must be submitted on a form provided for that purpose as issued within the Document Set, together with a certified check or a bid bond not less than five (5%) percent of the bid, payable to the City of South Milwaukee as a guarantee that, if the bid accepted, the bidder will execute and file the contract and a performance bond in the amount of one hundred (100%) percent of the total proposal price within ten (10) working days after the award of the contract. Failure to execute such contract and performance bond shall be cause for forfeiture of the check or bid bond as liquidated damages.
