NOTICE TO CONTRACTORS
ADA Compliant Curb Ramp Installation
Milwaukee County Community Development Block Grant Program
&
Concrete Sidewalk Replacement**

Notice is hereby given that sealed proposals will be received in the office of the City Clerk of the City of South Milwaukee at the Administration Building, 2424 15th Avenue, South Milwaukee, WI 53172 **until 11:00 a.m. on Tuesday August 20, 2019**, at which time they will be publicly opened and read for the above public works improvement contract which will include 2 parts: Part A: installation of ADA compliant curb ramps and Part B – Replacement of hazardous concrete sidewalk, with the following items of work:

- Concrete Curb & Gutter Removal & Replacement 250 L.F.
- Concrete Sidewalk (5") 6,000 S.F.
- Concrete Curb Ramp (6") 600 S.F.
- Concrete Ramp Detectable Warning Field 40 S.F.
- Asphalt Milling & Replacement 500 S.Y.
- Pavement Marking Crosswalk – 24" Ladder Pattern 200 L.F.
- Quantities of unclassified excavation, base aggregate and lawn restoration.

The document set describes items and quantities for bid proposal. It is anticipated that a contract will be awarded by the South Milwaukee Common Council on August 20, 2019 and the work shall be complete by November 15, 2019.

SPECIAL NOTICE TO CONTRACTORS: A portion of this project as described in documents is funded by the U.S. Department of Housing and Urban Development through the Milwaukee County Community Development Program. Firms bidding on this project are advised the awarded firm shall be required to:

- (1) Implement federal labor standards provisions and pay employees wages and fringe benefits at levels that meet or exceed a federal or state wage decision (included in bid documents);
- (2) Submit weekly payroll forms to South Milwaukee. South Milwaukee will forward to Milwaukee County with each invoice or payment request.
- (3) Use Minority Business Enterprises for at least 20% and Women Business Enterprises for at least 5%, of total contract amount, this may be satisfied through subcontracts and/or the purchase of services or supplies; and
- (4) Comply with all regulations and procedures established by the U.S. Department of Housing and Urban Development and Milwaukee County for this project, and ensure all subcontractors also comply.
- (5) Document compliance with Equal Employment Opportunity requirements; and
- (6) Provide a Dun and Bradstreet Number for prime and all sub-contractors or suppliers and evidence that the firm is not on the Federal list of debarred contractors.

Proposal must be placed in a sealed opaque envelope addressed to: **“City Clerk, City of South Milwaukee, Wisconsin”** and marked **“Proposal for ADA Compliant Curb Ramp Installation & Concrete Sidewalk Replacement.”** If the bid is sent by mail, the sealed envelope shall be enclosed in a separate mailing envelope with the notation **“Sealed Bid Enclosed”** on the face thereof.

STATUTORY PROVISIONS: The contract letting shall be subject to the provisions of the Wisconsin Statutes, including Section 62.15, 66.0901, 66.0903, 779.14 through 779.16. Minimum wage scales to be paid on the project shall be in accordance with the prevailing wage rates per the U.S. Department of Housing & Urban Development Davis-Bacon Labor Standards.

The City of South Milwaukee reserves the right to reject any or all bids and waive any informalities in the bidding. No bids shall be withdrawn after the opening of the bids without the consent of the City of South Milwaukee, Wisconsin, for a period of thirty (30) days after the scheduled time for closing bids.

All proposals must be submitted on a form provided for that purpose as issued within the Document Set, together with a certified check or a bid bond not less than five (5%) percent of the bid, payable to the City of South Milwaukee as a guarantee that, if the bid accepted, the bidder will execute and file the contract and a performance bond in the amount of one hundred (100%) percent of the total proposal price within ten (10) working days after the award of the contract. Failure to execute such contract and performance bond shall be cause for forfeiture of the check or bid bond as liquidated damages.
